

BOLIP YOUTH MINISTRY OFF SITE LIABILITY WAIVER

In consideration for being invited by Bread of Life in Portland Church (BOLIP) to participate in the **off site special events** organized by BOLIP located off site from the premises of the facilities located at 550 NE 76th Avenue, Portland, Oregon occurring on _____ (date), we (I) being twenty-one (21) years of age or older, do for ourselves (myself) [and for and on behalf of my youth participant, if my youth is not yet twenty-one (21) years of age or older] hereby release, forever discharge and agree to hold harmless BOLIP, its employees, directors, officers, staff members, volunteers, agents, successors, and assigns (collectively "released parties") from any and all liability, claims or demands for personal injury, sickness or death, as well as property damage and expenses, of any nature whatsoever which may be incurred by the undersigned and the youth participant that occur while said youth is participating in an off-site special event.

Furthermore, I/we being twenty-one (21) years of age or older, do for ourselves (myself) [and for and on behalf of my youth participant, if my youth is not yet twenty-one (21) years of age here] hereby assume all risks of personal injury, sickness, death, damage and expense as a result of participation in any and all off site special events, meetings and gatherings related to youth ministries.

Additionally, I/we give authorization and permission to BOLIP or its representatives to furnish any necessary transportation for my youth participant. This release covers transportation provided by BOLIP and their representatives who are properly licensed to drive in the State of Oregon and State of Washington and who will be driving the youth to/from BOLIP and to/from any other off site event location for the sole purpose of attending the off site special event program and activities. Any deviation from the route to/from BOLIP and to/from off site special event program is not covered under this waiver. And should it become necessary for the youth participant to return home due to medical reasons, disciplinary action, or behavior requiring special attention, we (I) hereby assume all associated transportation costs.

I/We give authorization and permission to BOLIP or its representatives to furnish any food and non-alcoholic beverages to my youth participant. I/We will be responsible to make known my son's/daughter's food and beverage allergies. Reasonable measures will be taken to make sure food and beverage allergies are avoided for youth participants who may be susceptible to certain dietary allergens.

Further, authorization and permission is hereby given to said church to assist in furnishing any necessary lodging for my/our youth participant. Lodging safety is guaranteed to the extent reasonable by the off site hotel or conference center organization providing the accommodations.

The undersigned further hereby agree to hold harmless and indemnify Bread of Life in Portland (BOLIP), its employees, directors, staff members, volunteers, agents, successors, and assigns for any injury, harm or death sustained by said church as the result of the negligent, willful or intentional acts of my/our youth participant, including any expenses incurred as a result of his or her acts.
